WHY ARE CYBER CRIMES HARD TO PROSECUTE?

Jurisdiction is the No. 1 barrier to prosecuting cyber crime. Most of the time, the person committing the crime is located outside of the country (or at least outside the legal jurisdiction of the court and prosecutors seeking the conviction). It's hard enough to successfully prosecute a cyber criminal if they originate in the same jurisdiction as the victim, but close to impossible when both reside in different locations.

Many times we successfully collect good legal evidence and even verify the identity and location of the cyber criminal, but we have no legal ability to arrest the person. We have established cross-boundary, reciprocal legal rules with many cyber allies, but many more countries don't and won't participate. China and Russia will never honour our warrants of arrest any more than we would honour theirs.



NEWS: PUDUCHERRY (INDIA)

Police have arrested a 32-year-old man from Tirupur who they said forced a 16-year-old girl from Puducherry to send him compromising photos and videos and threatened to upload them on social media. K Kamalakannan, a Thanjavur native married and settled in Tirupur, was later sent to Puducherry Central Prison.

Police said the girl, given a smartphone by her parents to attend online classes, created accounts on social media including Facebook and sent friend requests to several people including Kamalakannan.

The man, posing as a teenager, began chatting with her and his profile picture, that of a smart-looking boy, deceived her and she fell in love, an officer said. On Kamalakannan's request, she sent photos and videos through Facebook messenger.

Hence, overprotective parents cannot be blamed for monitoring their children closely.

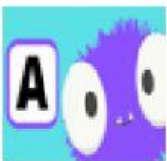
