

Calculating Deductions and Net Pay

- Instructions:
1. Calculate Before-Tax Deductions (if there are any).
 2. Calculate the Gross Taxable Income
 3. Calculate Provincial Income Tax (10.5%), Federal Income Tax (15%), and EI (1.58%)
 4. Calculate CPP (Gross Taxable annual - \$3500 annual)(5.70%) for 1 week
 5. Calculate Total Taxes, EI and CPP
 5. Calculate Total Deductions (Taxes, EI, CPP and Before Tax Deductions)
 6. Calculate Net Pay
