Hurricane Dorian affected The Bahamas from September 1st to September 3rd, 2019 as a category 5 storm. It battered the islands of Abaco and Grand Bahama for over two days. The flooding lasted for days after the hurricane. The floods and debris also hindered persons from giving aid to those who needed it.

Hurricane Matthew began affecting The Bahamas around October 4, 2016 as a category 4 storm also. It affected almost every island in our archipelago but major wind and surge damage affected islands such as New Providence and Grand Bahama. The coastal residence on the south of New Providence were mainly affected by the surge.
