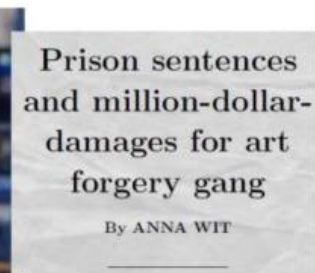


Read seven news headlines and find seven crimes that match the meanings given below.

record. Now he works full-time as an office clerk and has good chances of not becoming a repeat offender and going back to prison.
