A Faro studies the problems that migrants have when they first come to the host country, whereas Griffiths examines those of second generation migrants.

B They have also been very successful in strengthening the British economy. It seems unlikely the country would have developed its economy so fast without this sudden influx of workers.

C Griffiths touches on the growth of the second generation of communities in the UK and argues that it is growing fast, leading to a much more multicultural society in the UK.

D According to Faro, there are major problems for migrants when they first arrive in the community. The failure of the government to provide cultural integration and language programmes results in migrants identifying even more with their home country.

E She also disputes Faro's argument that the government is not doing enough for the communities by focusing on the efforts to improve education in the communities.

F Faro also observes that migrant workers are much more motivated to work than a citizen of the home country.

G Faro (2008) and Griffiths (2005) approach the issue of the migrant communities from two different directions. Both of them have very different ideas about the migrant communities.

H Griffiths notes the cultural crisis in the community but his argument differs from Faro. In Griffiths' view, children of the second generation can do a lot to close the gaps between the two communities.
