Felicia's Accident

Felicia was driving to work one day when a man in a blue pickup truck pulled out in front of her at an intersection. Felicia tried her best to swerve and miss the truck. She went right, then left, and then hit the back of the pickup. Both the car and the truck stopped immediately. Both drivers moved their vehicles to the side of the road after the accident, so that other cars would not hit them.

Felicia turned on her warning flashers to alert other drivers to the accident. She then checked to see if the other driver was hurt. Luckily for Felicia, she was wearing her seat belt. The driver of the pickup was not wearing a seat belt. He had bumped his head. He had a small cut over his eye. Felicia found a cloth to help stop the bleeding.

Next, Felicia went into a nearby restaurant to call the police. She also called her boss and told her she would be late to work. Then she went back to her car to wait for the police to arrive.

While they were waiting, Felicia and the man exchanged some information: names, addresses, driver's license numbers, license plate numbers, the names of their insurance companies, and insurance policy numbers.

They both stayed at the scene of the accident until the police came. The police investigated the accident and told them they could leave.
