Motorcyclist Injured in Collision with Car on Oak Avenue

Daily News - A motorcyclist was injured in a traffic accident on Oak Avenue yesterday evening. The crash occurred at approximately 7:30 PM when a car suddenly switched lanes without signalling, causing the motorcyclist to lose control and fall onto the road.

The injured motorcyclist, a 30-year-old man, suffered a fractured arm and several bruises. He was immediately taken to the local hospital for medical treatment. The driver of the car, a 45-year-old woman, was unharmed and cooperated with authorities during the investigation.
