### Motorcycle and Truck Collision Causes Traffic Jam on Highway 45

Metro News - A collision between a motorcycle and a truck caused a major traffic jam on Highway 45 yesterday afternoon. The accident occurred around 3:00 PM when a motorcycle attempted to overtake a slow-moving truck but miscalculated the distance. As a result, the motorcycle hit the side of the truck and fell onto the road.

The motorcyclist, a 28-year-old man, suffered moderate injuries and was taken to the nearest hospital for medical treatment. The truck driver was not injured and remained at the scene to assist the police in their investigation.
