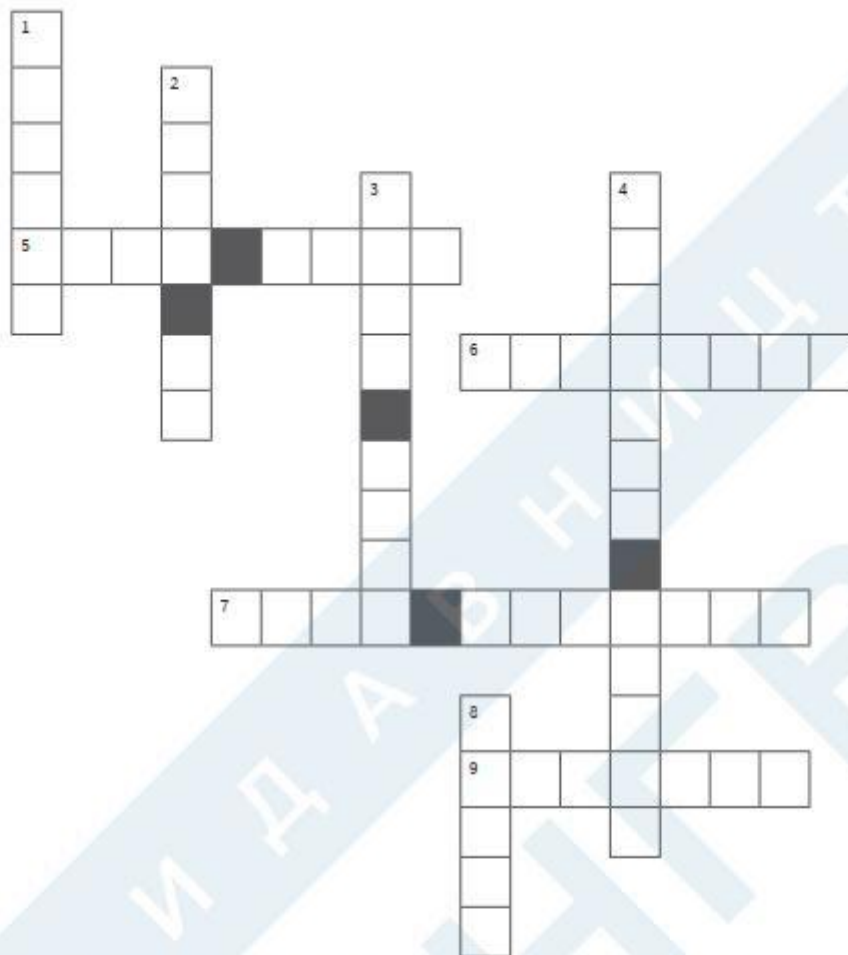




- 1 you get this back if you pay more for something than it costs
