So what motivated Shaun Greenhalgh to enter into a ¹ (conspire) and ² (fraud) the art world of thousands of pounds? It appears that it wasn't for the money because the family continued to live a modest lifestyle even when they had acquired a small fortune. There's no question that Shaun was an ³ (accomplish) artist, but also an ⁴ (assume) character, so why create so many ⁵ (forger) and risk ⁶ (prison)? His lawyer, however, said he made the copies to 'perfect the love he had for such arts'.

The fine art of forgery

Meet Shaun Greenhalgh, painter, sculpture, wood carver ... and criminal.

Over a period of 17 years, until his imprisonment in November 2007, Shaun created over 120 breathtaking works of art, not from an inspiring and well-equipped studio, but from his garden shed in Bolton, Greater Manchester.

This unassuming man of 47, who had never had an art lesson in his life, became one of the most accomplished art forgers in Europe.



The inspiration for his work came from library books, which detailed lost masterpieces from around the world. Shaun undertook meticulous research and learnt a staggering range of techniques to be able to create his copies, everything from pastels and watercolours, to ancient and modern sculpture, and metalwork. Both the tools he used from the local DIY store and his methods of ageing his work were fairly rudimentary, but Shaun and his accomplices managed to fool all areas of the art world including dealers, auction houses, museums and private collectors.

So who else was in this gang? A network of wealthy and well-connected fraudsters? In fact, Shaun's 'gang' turned out to consist of himself, and his elderly mum and dad, who all lived together in their small and somewhat shabby council house. While Shaun worked away in his shed recreating 'lost' art treasures, his father, George, was the salesman in the team. He made up colourful stories about each of the fakes to explain the provenance of each item. Working together with his wife, Olive, they even acquired catalogues for antique sales to further authenticate Shaun's work. It is estimated that they made up to £850,000 in their 17-year collaboration.

By far their most daring forgery was The Armana Princess – a statue thought to represent of the daughter of Pharaoh Akhenaten and Queen Nefertiti, the mother of King Tutankhamun. The original would have been over 3,000 years old while Shaun's version was created in about three weeks using basic tools, and aged using a mixture of tea and clay. George's role was to approach Bolton Museum with a simple enquiry about the statue.

He claimed it had been passed down the generations in his family for about 100 years and that he thought it might be worth a few hundred pounds. Experts from the British Museum and auction house Christie's assessed the authenticity and potential value of the statue. On their recommendation, Bolton Museum offered George £440,000 for the statue, which of course he gladly accepted.

Finally, in November 2005, the family's luck ran out. They tried to sell three 'Assyrian' stone tablets, which were supposed to date back to 681BC, at a value of about £500,000. George maintained they had been in his family since he was a child. An

expert at the British Museum spotted a mistake in the hieroglyphic-style writing on one of the tablets.

The Museum informed the police, who raided the family home and found a huge collection of fakes, including Shaun's three previous attempts at The Armana Princess. All three admitted conspiracy to defraud and Shaun received a prison sentence of just under five years.

- forgery:** a person who makes illegal copies of something
- council house:** a house owned by the council and rented to tenants
- provenance:** a record of ownership of a work of art or antique
- tablet:** a piece of stone, clay, or wood on which an inscription is written
