The 13 Colonies were a group of British colonies on the Atlantic coast of North America. There were founded in the 17th and 18th centuries. They began fighting the American Revolutionary War in April 1775 and formed the United States of America by declaring full independence in July 1776. Moreover, the three forms of colonial government in 1776 were provincial (royal colony), proprietary, and charter.

Regarding religion, Protestantism was the predominant religious affiliation in the Thirteen Colonies, although there were also Catholics, Jews, and deists, and a large fraction had no religious connection. An interesting fact is that the Massachusetts Colony was founded by John Winthrop and other Puritans, at Massachusetts Bay. And that Maryland was the Fourth Colony to be established in Colonial America. Concerning the motives why the colonies were established, political, religious, and economic contributed to the settling of the Atlantic seaboard. Both labour and capital in England had become fairly fluid by 1600 and were seeking more profitable fields.
