By 1690, 250,000 people lived in the New World. By 1790, there were 2.5 million people.

People came for different reasons. Some left their homes to escape the war. Others sought political or religious freedom. 2) Some, like black Africans, arrived as slaves.

In time, the 13 colonies developed within three distinct regions.

The first settlements were along the Atlantic coast and on rivers that flowed into the ocean. In the Northeast, trees covered the hills and stones filled the soil, but water power was available. The Northeast was called New England, and it included Massachusetts, Connecticut, and Rhode Island. 3).....
