EPISODE 1 — FIRST HALF

In 1983, in a US Department of Energy laboratory in the town of Hawkins, Indiana, a scientist is attacked by an unseen creature. 12-year-old Will Byers vanishes after encountering the creature while riding his bicycle home from a *Dungeons & Dragons* session with his friends. The next day, a young girl with a shaved head, wearing a hospital gown, steals food from a local diner.
