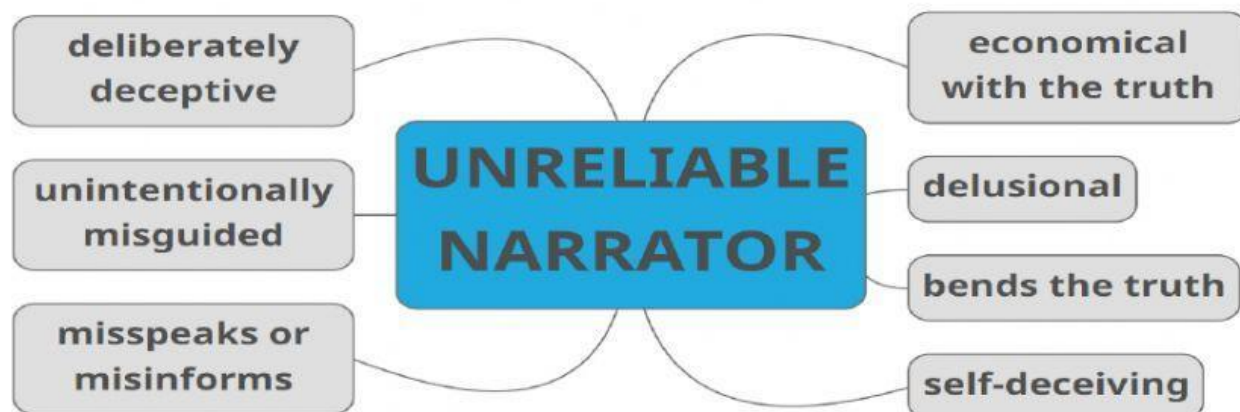

This film is a throwback to classic detective noirs. In 1954, a U.S. Marshal investigates the disappearance of a murderer who escaped from a hospital for the criminally insane. The Narrator is lying to himself and to the audience.

2. _____

A sole survivor tells of the twisty events leading up to a horrific gun battle on a boat, which began when five criminals met at a seemingly random police lineup. The narrator had been deceiving the characters in the movie, and hence the audience, by the story he is telling.

3. _____

In the 1999 film, it is revealed that the narrator suffers from dissociative identity disorder and that some events were fabricated. The Character Tyler Durden has something to do with the unreliable narrative.

4. _____

The rape of a bride and the murder of her samurai husband are recalled from the perspectives of a bandit, the bride, the samurai's ghost and a woodcutter.

5. _____

A frightened, withdrawn Philadelphia boy who communicates with spirits seeks the help of a disheartened child psychologist. The Narrator himself doesn't know what is happening around him.

6. _____

With his wife's disappearance having become the focus of an intense media circus, a man sees the spotlight turned on him when it's suspected that he may not be innocent. Amy and Nick both are unreliable narrators, they are lying to the audience in the full first half of the movie.

7. _____

In Gotham City, mentally troubled comedian Arthur Fleck is disregarded and mistreated by society. He then embarks on a downward spiral of revolution and bloody crime. This path brings him face-to-face with his alter-ego.
