**Four killed in California backyard shooting: police**

Four people were shot dead and six others wounded while watching a football game in the backyard of a central California home on Sunday, police said. Police were called to the scene after at least one person opened fire into a crowd of about 35 people gathered outside the house in Fresno, around 200 miles (320 kilometers) north of Los Angeles

"Three people died on scene," Fresno deputy police chief Michael Reed told reporters, adding that a fourth was rushed to hospital in critical condition and died due to his injuries there.

All four of the dead and the six treated for "non-life-threatening" gunshot wounds were men aged between 25 and 35, Reed said.

"Our heart goes out to the families of the victims... this is senseless violence, he added.

"We are doing everything we can to bring the perpetrators to justice."

Reed said it was unclear how many perpetrators had been involved in the shooting and that there was "no indication" the incident was gang-related.

Police spokesman Bill Dooley said officers were looking for surveillance footage and witnesses to track the suspects.

Choua Vang, who lives near the site of the attack, said that Sunday's incident was the second shooting in the area in as many weeks.

"It makes me feel unsafe to be outside when the sun's down," he told the Fresno Bee newspaper.

The police are investigating an explosion that took place in the back yard of the Parepare Prosecutor's Office in South Sulawesi on Tuesday afternoon.

National Police spokesman Insp. Gen. Muhammad Iqbal confirmed the incident but refused to give details about the cause of the explosion as the investigation is still ongoing.

"We don't know where the blast came from. It happened at 2:45 p.m. in the back yard of the Parepare Prosecutor's Office," he said in Jakarta on Tuesday as reported by *kompas.com*.

He said it was still unknown whether a low or high explosive had been used. The Parepare police have deployed a bomb squad to investigate the site and assess the possibility of another explosion.

No casualties have been reported in the incident. The blast caused some damage to the building, Iqbal said, although he could not yet give details on the level of destruction. (vla)

**House-invading ants can get into your food, damage property or cause stinging bites. These tiny creatures can also cause damage to your plants.**

Dealing with ants can be very frustrating. Pesticides for ants contain chemicals that are **harmful** to humans and the environment, but there are some natural, non-toxic ways to control ants. These may take some time and patience, but will provide good results.

White vinegar will send an eviction notice to ants on your premises. They cannot bear **its** strong smell. In addition, the smell masks their **scent** trails, making them lose their direction.
