

Types of Hotels by Location

- City Hotel

City Hotel is a type of hotel located in urban center areas and is generally more commonly found in big cities. City hotels are usually large in size with multi-storey buildings with business facilities because guests who stay at this type of hotel are mostly business travelers. This makes this type of hotel also often referred to as a business hotel or business hotel.

- Motel (Motor Hotel)

Motel stands for motor hotel. It is so named because this type of hotel is intended as a temporary stopover for people who are traveling long distances. Motels are usually on the edge of connecting roads between cities or regions.

- Resort Hotel

This next type of hotel may already be quite popular for you traveling fans. Resort Hotel is a type of hotel that is located far outside the urban center and is located in tourist and recreational areas such as beaches, mountains, lake or river banks and the like.

- Residential Hotel

As the name implies, this type of hotel is located in a residential area away from the crowds. Residential hotels are usually the choice for guests who plan to stay for a long time. Although far from the crowds, this type of hotel remains in an area with easy access to reach the center of activity in the city.

- Downtown Hotel

On the other hand, Downtown Hotel is a type of hotel that is located in the center of the crowd, namely the trade and shopping area. This type of hotel is usually intended for business travelers who have the purpose of a business trip involving trade and buying and selling.

Types of Hotels by Plan

- Full American Plan (FAP), is a type of hotel that uses a system where the room price includes 3 meals.
- Modified American Plan (MAP), is a hotel that uses a system where the room price includes 2 meals.
- European Plan (EP), is a hotel that uses a system where room rates do not include meals.
- Continental Plan (CP), is a type of hotel that uses a system where room rates include breakfast.

Types of Hotels based on the Purpose of Visiting Guests

- Business Hotel

This type of hotel has most of its guests doing business activities, so generally the location of the hotel is in the city center or the center of the crowd such as the City Hotel or Downtown Hotel.

- Resort/Tourism Hotel

This type of hotel where most of the guests are tourists, both domestic and foreign. This type of hotel is usually located near tourist sites, complete with leisure facilities.

- Casino Hotel

This type of hotel is intended for guests who want to play casino. Not only close to the casino location, this type of hotel even has many casino facilities in it.

- Pilgrim Hotel

This type of hotel aims to accommodate guests who have the purpose of traveling for worship or pilgrimage.

- Cure Hotel

In this type of hotel, most of the guests are guests who are in the process of treatment or care, so that the location is usually close to major hospitals.

Types of Hotels by Class or Star

- One Star Hotel

One star hotel has a minimum number of standard rooms 15 rooms with a minimum standard room area of 20 m²

- Two Star Hotel

Two-star hotel has a minimum number of standard rooms 20 rooms with a minimum standard room area of 22 m² and a minimum suite room 1 room with a minimum suite room area of 44 m²

Facilities: Has telephone and television in the room, there is a sports venue, restaurant.

- Three Star Hotel

A three-star hotel has a minimum number of standard rooms 30 rooms Rooms with a minimum standard room area of 24 m² and a minimum suite room 2 rooms with a minimum suite room area of 48 m²

Facilities: Has telephone, television, and air conditioning in the room, there are recreational and sports facilities, restaurant and bar and provides concierge staff.

- Four Star Hotel

A four-star hotel has a minimum number of standard rooms 50 rooms with a minimum standard room area of 24 m² and a minimum suite of 3 rooms with a minimum suite room area of 48 m²

Facilities: Has telephone, television, air conditioning, and water heater in the room, there are recreational and sports facilities, rest area, restaurant and bar and provides Concierge Staff.

- A five-star hotel

Five-star hotels have a minimum number of standard rooms 100 rooms with a minimum standard room area of 26 m² and a minimum suite of 4 rooms with a minimum suite room area of 52 m².

Facilities: Has telephone, television, air conditioning, and water heater in the room, there are recreational and sports facilities, rest area, restaurant and bar and provides concierge staff and 24-hour room service.
