

Calculating Earnings: Wage(Hourly Rate)

- Daily Earnings= hourly rate x # hours worked

 What is the daily wage?			
Hourly Rate	Daily Hours	rate x hours	Daily Wage
\$15.55	5	x	
\$15.00	8	x	
\$14.55	3	x	
\$15.75	6.6	x	
\$16.25	4	x	
\$15.15	4.5	x	

Weekly Earnings = hourly rate x # hours worked x days



What is the weekly wage?

Hourly Rate	Daily Hours	Days Worked	rate x hours x days		Daily Wage
\$15.55	5	5	x	x	
\$15.00	8	5	x	x	
\$14.55	3	7	x	x	
\$15.75	6.6	4	x	x	
\$16.25	4	6	x	x	
\$15.15	4.5	3	x	x
