- Why do you think people risk so much to steal money from others?

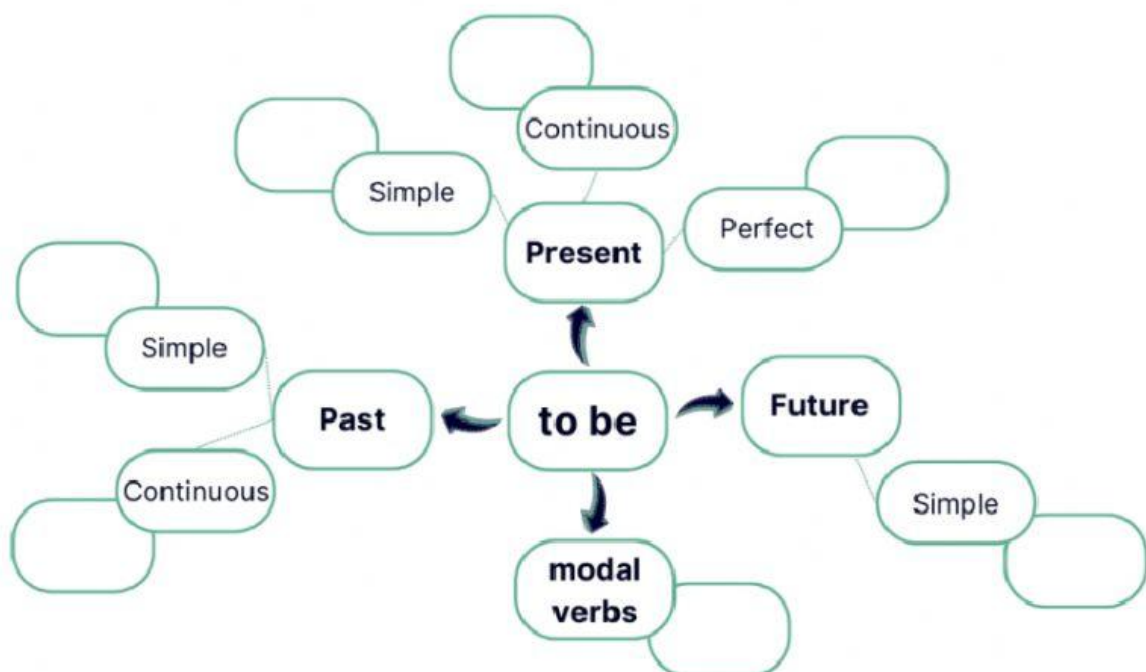
