


V- THE CIVIL RIGHTS MOVEMENT: Look, read and watch.



**1- A WOMAN WHO FOUGHT FOR EQUAL RIGHTS**

Rosa Parks (1913 - 2005) came from Alabama, USA.

On December 1, 1955, she broke the law. Her crime was to take an empty seat at the front of a public bus, whereas those seats were reserved for white people. At that time, there were segregation laws in the South of the US and African Americans weren't allowed to enter public places (restaurants, cinemas...). They were also forbidden to attend some schools.

Rosa Parks had to go to jail for one day. However, her act of bravery launched a series of events that changed the country. African Americans showed their discontent by refusing to ride the buses in Montgomery. Martin Luther King led this boycott which lasted 381 days.

In 1956, the Supreme Court declared that African Americans could sit wherever they wanted. In 1964, The Civil Rights Act banned all racial discrimination in public places. That's why the world continues to remember and honor her.

**The Civil Rights Movement** began in the United States in the mid-1950s. Its aim was to establish equal rights for black and white people and to abolish racial discrimination.

- After her trial, the black community organized a bus boycott to protest.

- More white people got on the bus, so the driver moved the colored section further back.
- The bus company lost a lot of money.
