To reduce the amount of food wasted by supermarkets, legislation should be introduced. Food labelling laws in the UK provide a good example of this. Knox (2014) says that food labelling has been simplified by removing 'sell by' dates. Another example of government legislation can be seen in France where governments have banned supermarkets from throwing edible food away, instead forcing them to donate it to charity (Knox). Similarly, the Italian government uses tax incentives to encourage supermarkets and businesses to donate food (Knox, 2014). Food donation charities, such as Ozharvest (Varga, 2013), also exist in Australia so the Australian government could easily follow the examples set by France and Italy.
