NEVER PARK OR LEAVE YOUR VEHICLE:

- 1) WHERE A "NO PARKING" SIGN IS _____.

- 5) IN THE SPACE NEXT TO A DISABLED PERSON PARKING SPACE, IF IT IS PAINTED IN A _____ (DIAGONAL) PATTERN.
- 6) IN A SPACE DESIGNATED FOR PARKING OR FUELING ZERO _____ VEHICLES THAT DISPLAY AN IDENTIFYING DECAL, UNLESS YOU ARE DRIVING A ZERO EMISSION VEHICLE THAT YOU WILL CHARGE IN THE SPACE.
- 7) IN A TUNNEL OR ON A _____, EXCEPT WHERE PERMITTED BY SIGNS.
- 8) WITHIN 15 FEET OF A FIRE _____ OR A FIRE STATION DRIVEWAY.
- 9) ON OR WITHIN 7.5 FEET OF A _____ TRACK.
- 10) BETWEEN A SAFETY _____ AND THE CURB.
- 11) "_____ PARKED" (PARKING IN THE STREET WHEN ALL LEGAL PARKING PLACES AT THE CURB ARE TAKEN).
- 12) ON THE _____ SIDE OF THE STREET.
- 13) AT A _____ CURB.
- 14) ON A _____, EXCEPT:
