Virginia and the New American Nation

1 The first successful English settlement in North America was in Virginia. People of Virginia and their actions have shaped our nation as we know it today. Virginians were influential around the time of the Revolutionary War in forming our government.

2 The Revolutionary War began on April 19, 1775. There were many causes of the Revolutionary War. The main cause though, was the colonists, including Virginians, felt they deserved the same rights as the people of England.

However, the British government continued to treat the colonists poorly by passing many unfair acts and taxes. The colonists were being taxed without representation.

3 George Washington, the *Father of Our Country* and our first president, provided strong leadership before, during, and after the Revolutionary War. His leadership provided a model for future presidents. He is remembered for helping to develop the new American Nation. He was a general during the Revolutionary War and helped to win the war against England.

4 As the Revolutionary War progressed, many documents were written by Virginians. They wanted to write about the rights and freedom the people of Virginia should have. The *Virginia Declaration of Rights* was written by George Mason in June of 1776. This document outlined the rights of Virginians. Those rights included freedom of religion and freedom of the press. This document influenced other documents written for America including the Declaration of Independence and the Constitution. In 1777, Thomas Jefferson drafted the *Virginia Statute for Religious Freedom*. This documents states that people should be free to worship how they please.

George Washington provided military leadership by serving as the commander-in-chief of the Continental Army.

Thomas Jefferson wrote the Virginia Statute for Religious Freedom.

5 Both the *Virginia Declaration of Rights* and the *Virginia Statute for Religious Freedom* influenced the writing of the Constitution of the United States. James Madison was a Virginian who grew up on a tobacco farm. He went to school to become a lawyer. Later, he became part of the Continental Congress. The Continental Congress consisted of representatives from the thirteen colonies. They worked to govern the states during the Revolutionary War. Madison worked hard to keep the colonies united. When the War was over, Madison felt the country needed a full constitution. He worked hard during the Constitutional Convention. He helped the delegates from the states write the Constitution which was signed in 1787. James Madison is often referred to as the "Father of the Constitution."

6 The beliefs and actions of Virginians such as George Washington, Thomas Jefferson, George Mason, and James Madison all helped to shape the new American nation. Their beliefs built our government and provided all Americans with the freedoms we enjoy today.
