

## Law and order: In court

There are two main courts of law in Britain - the (1) \_\_\_\_\_ for minor offences, such as speeding, shoplifting, etc. and the (2) \_\_\_\_\_ for more serious offences such as fraud and murder. The magistrate or (3) \_\_\_\_\_ who tries cases in the lower court does not have special education or training in law and does not get a salary. (The job is voluntary and part-time.)

At a (4) \_\_\_\_\_ at a Crown Court, the (5) \_\_\_\_\_ or defendant stands in the (6) \_\_\_\_\_ while lawyers question (7) \_\_\_\_\_ who have to say what they have seen or know and who stand in the (8) \_\_\_\_\_. The (14) \_\_\_\_\_ sits in a large seat facing the defendant and wears a special gown and wig. He or she does not decide whether the accused person is guilty or not. This is left to the (15) \_\_\_\_\_, made up of 12 members of the public to decide. During the trial they sit in silence, listening carefully to all the (16) \_\_\_\_\_.
