

1. Kompetensi Dasar

2. Materi Pokok

Label obat/makanan/minuman adalah teks yang tertera pada bungkus/kemasan produk yang memuat deskripsi rinci tentang produk maupun cara menggunakannya. Kemampuan memahami label dapat meningkatkan kecerdasan peserta didik dalam menentukan produk yang akan dibeli atau digunakan, dan jika telah memilih, peserta didik mampu menggunakan produk tersebut secara tepat sehingga mendapatkan manfaat sebaik-baiknya dari produk serta dapat menghindari hal-hal yang tidak baik dan tidak aman ketika menggunakannya.

3. Topik

Informasi tentang obat/makanan/minuman yang dapat menumbuhkan perilaku yang termuat di Kompetensi Inti (KI)

4. Fungsi Sosial

Memilih obat/makanan/minuman yang sehat dan aman, menghindari efek negatif dan mendapatkan hasil terbaik.

5. Struktur Teks

Dapat mencakup nama asli dan nama dagang obat, deskripsi, volume, bahan, cara menggunakan, cara menyimpan dan tanggal kadaluarsa.

6. Unsur Kebahasaan

- Istilah khusus terkait dengan produk
- Kalimat inferatif
- Tata bahasa : frasa nominal untuk menyebutkan benda, cara menyebut jumlah atau ukuran
- Ucapan tekanan kata, intonasi, ejaan, tanda baca dan tulisan tangan.

1. Definition of label

A label is a piece of paper, plastic film, cloth, metal, or other material affixed to a container or product, on which is written or printed information or symbols about the product or item. Information printed directly on a container or article can also be considered labeling. Product labels can be made from a variety of materials. Common materials include: paper or cardboard (often attached with plastic, twine or metal staples), cloth, metal (often aluminum), and plastic. Dari definisi di atas kita bisa menyimpulkan bahwa **Label** adalah teks yang dituliskan di bungkus produk, atau diselipkan di dalam bungkus produk, atau ditempelkan di produk untuk memberikan informasi rinci dari produk tersebut.

3. Social Function

- To give detailed information of the product (untuk memberikan informasi rinci tentang sebuah produk)
- It is used to identify type, size, brand, product line, manufacturer and other product-specific information in order to inform the consumer and encourage a purchase.
- To choose healthy and safe products (agar dapat memilih produk yang sehat dan aman)
- To avoid harmful effects (untuk menghindari efek samping yang membahayakan)
- To get the best result (untuk mendapatkan hasil terbaik)

4. Language Feature

Unsur kebahasaan untuk memahami label produk obat, makanan dan minuman.

- a) Ungkapan dan kosa kata yang lazim pada setiap produk obat, makanan dan minuman
- b) Tata bahasa :
 - Kalimat Imperative (Command and Prohibition)
Command = V1 + O
Example : Use the soft material!
Shake well before use!
 - Prohibition
 - a. Do not + V1 + O
Example : Do not consume after expired ate!
 - b. No + Ving + complement
Example : No accepting if the seal is broken!
