III. Assume that you're a Social Worker, propose a program and explain it in 3-5 to resolve the given societal issues below: (10 points)

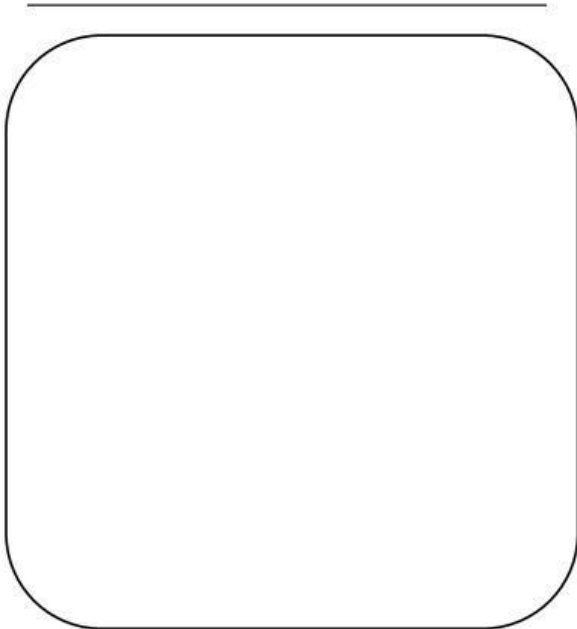
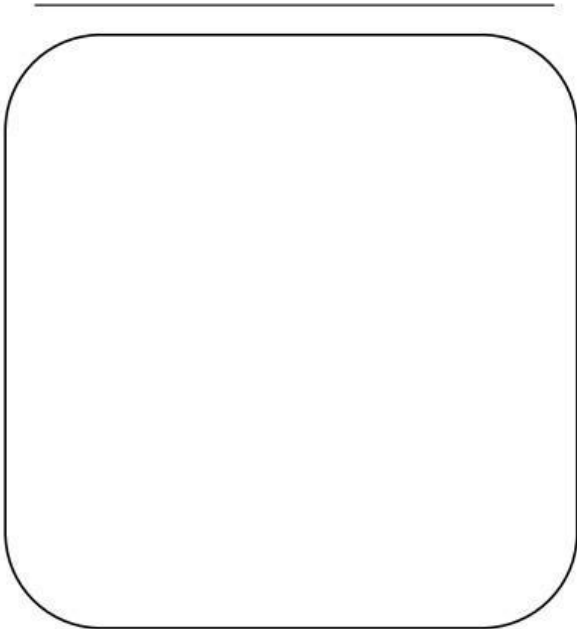
