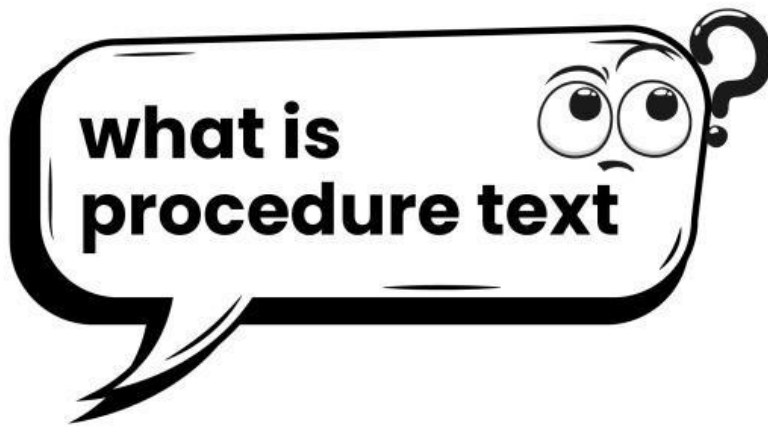
Raka gave her the sandwich and said, "Enjoy your breakfast! I made it myself!"

Procedure text can be defined as a type of text that informs about **how to do, make something, complete a job or activity** in a step-by-step process.

For example :

- how to make a cake
- how to wash a cloth
- how to make a sandwich

One of the most common is a procedure text on how to make food and drinks

The purpose of procedure text is to explain how to make, do or operate something with step-by-step or clear and sequential instructions..

generic structure

- **Title**

The name of the activity or the thing to make.

- **Ingredients/Materials**

tools/materials that will be needed to make something in the English procedure text.

- **Steps/Methods**

is the part that contains the steps we have to do to make something according to the procedure text.



language features

- **simple present tense**

Procedure text must be written using Simple Present Tense. This is because the procedure text contains command sentences about how to make or do something.

- **Imperative Sentences (Kalimat Perintah)**

imperative sentences always start with verb 1 of an action verb or a verb that involves physical activity. So, we don't need to use a subject at the beginning of the sentence.

- **Connectives (Kata Penghubung)**

connectives are used in a procedure text to connect the steps so that the list of instructions is coherent and easy to understand.

- **Adverb (Kata Keterangan)**

adverbs are used to give a description of time. There are 2 types of adverbs used in procedure text :

Adverb of time

an adverb of time that indicates how long you have to do something.

Examples: in 10 minutes, for 1 hour.

Adverb of manner

a description of how to do something.

Examples: slowly, well, evenly.

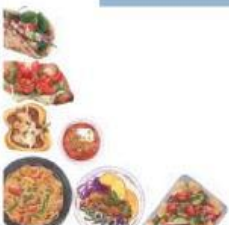
