Abolitionist Movement

A body of legal rules that governs the formation, enforcement, and interpretation of agreements between parties. It ensures that promises made in a contract are legally binding and outlines the remedies available if those promises are broken.

Alexander Hamilton

A fiscal policy where the government imposes minimal taxation on individuals and businesses.

Contract Law

A social and political campaign aimed at ending slavery and the slave trade, primarily in the United States, during the 19th century.

Embargo Act

Supporters of a strong national government who advocated for the ratification of the U.S. Constitution in the late 18th century; believed that a centralized government was essential for maintaining order and ensuring the country's survival

Federalists

A Founding Father and the first Secretary of the Treasury of the United States, who played a crucial role in shaping the financial system and political landscape of the new republic.

James Madison

The fourth President of the United States; known as the 'Father of the Constitution' for his pivotal role in drafting and promoting the U.S. Constitution and the Bill of Rights.

Louisiana Purchase

A law passed by the United States Congress that prohibited American ships from trading with foreign nations, primarily aimed at Britain and France during the Napoleonic Wars.

Low taxes

A significant land acquisition made by the United States from France in 1803, where the U.S. acquired approximately 827,000 square miles of territory west of the Mississippi River for \$15 million.
