Should Schools Mandate an Etiquette & Digital Citizenship Program to Address Declining Student Courtesy?

Numerous educators and parents notice that students nowadays frequently exhibit impoliteness, including disrespecting teachers, using devices during lessons, neglecting greetings, or making impolite remarks online. Some individuals believe this is merely a consequence of modernization, whereas others feel that schools need to implement more decisive measures. The primary issue is whether it is necessary for schools to require a program on etiquette and digital citizenship. Advocates contend that polite behavior can be integrated in the curriculum.

A well-organized curriculum featuring lessons on courteous communication, empathy, taking turns, and responsible online conduct would help students grasp the concept of respect in both physical and digital environments. Additionally, the program can establish uniform guidelines in every class so students learn self-regulation, communicate respectfully, and recognize cultural differences in interactions. Lessons on digital citizenship can assist students in utilizing social media responsibly, steering clear of cyberbullying, and honoring privacy.

Critics argue that directly teaching etiquette can seem unnatural. If the lessons are too rigid, students may only behave respectfully without genuine concern. Certain educators are concerned about losing time for core subjects. Some believe that proper etiquette starts in the household rather than in school, making collaboration with families more crucial than establishing additional school regulations.


A well-rounded strategy is necessary. Schools ought to introduce an etiquette and digital citizenship program that is engaging by utilizing role plays, peer feedback, and reflective practices rather than relying solely on educators. The rules should be developed alongside students to ensure they feel accountable rather than managed. When schools demonstrate respect and promote open communication, courtesy can develop organically into character and habit, instead of merely being a rule to adhere to.

Outline of a Discussion Essay

1. Introduction

2. Body Paragraph 1 — First Viewpoint

- **Supporting details:** Provide explanations, examples, evidence, or expert opinions.
- **Linking sentence:** Summarize or connect to the next paragraph.

- **Topic sentence:** Introduce the opposing side (e.g., disadvantages or counterarguments).
- **Supporting details:** Provide explanations, examples, or evidence.
- **Concession or balance:** Acknowledge valid points while maintaining a neutral or critical tone.
