### Case Study: Mr. Daniels

Mr. Daniels is a 58-year-old man **who/whom** visited the clinic last year after his blood pressure increased significantly. At today's appointment, he explains that he has recently experienced mild headaches **during/throughout** the mornings, which started three months ago. He reports that he has been taking the antihypertensive medication **that/which** the cardiologist prescribed, but he has not been exercising regularly.

Last year, he was advised to lose weight and reduce his salt intake. However, he admits that he **has tried/was trying** to follow the recommendations but struggled when he changed jobs and adopted a more sedentary routine. Because of this, he has gained six kilos over the past year.

The doctor reviews his results and tells him that the blood tests are normal, although he **may/could** need an adjustment in his medication if the high blood pressure persists. She also explains that if he **follows/will follow** the exercise plan consistently, he should start feeling an improvement within a few weeks. She warns him that untreated hypertension **can lead/could have led** to cardiovascular complications such as left ventricular hypertrophy or renal impairment.

Mr. Daniels seems motivated. He says that he **would have exercised/would exercise** more if he hadn't felt so fatigued lately, but he agrees to start walking every morning. The doctor finishes by asking whether he experiences shortness of breath, **for which/of which** she wants to rule out an underlying cardiac cause.
