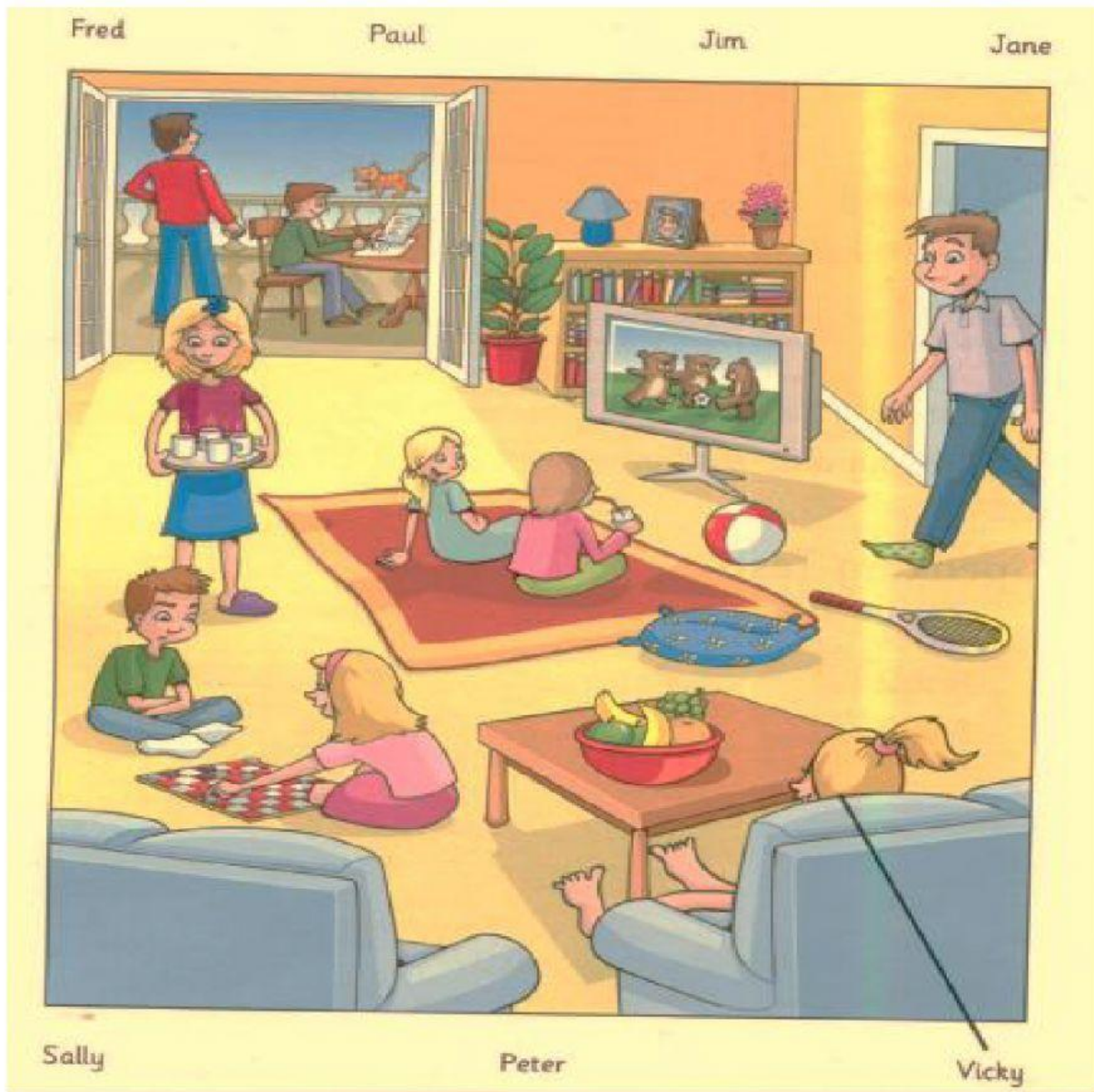

4.- Read the text about “ Responsibilities as a citizenship ” and answer the following questions



You **are a citizen of the country** you were born in. Usually, **citizens live in their country** as loyal members of society. Many countries also have options so people **who are not natural-born citizens** can become citizens of that country. When **they complete the requirements**, they are called **naturalized citizens**. As a citizen of your country, you have some **rights, duties and responsibilities**. U.S. law guarantees the rights of all citizens. It doesn't matter what U.S. state the citizen lives in; **the rights are the same for all citizens**. This is because the U.S. Constitution is the supreme law of the land. **The rights of citizens of the United States are**

protected in the Bill of Rights. The Bill of Rights **is the first ten amendments to the U.S. Constitution**. A citizen has the **right to speak freely and the right to religious freedom**. A citizen who is accused of a crime has a right to **a fair trial and a trial with a jury**. In exchange for their rights, citizens have duties and responsibilities. They have a duty to serve on a jury when asked. They should obey all laws. In wartime, they **must serve in the armed forces** when required to. **They must pay taxes** to support the services and programs of the government. Good citizens vote in elections to express their opinion on how the government should be run. In addition to a national citizenship, people are citizens of a state and a city. **They have similar rights and responsibilities** in each level of citizenship.
