In addition to Councils on Developmental Disabilities, the Developmental Disabilities Act ("DD Act") also created other partner agencies in every state and U.S. territory. These groups make up the state "DD Network" - state councils on developmental disabilities, protection and advocacy agencies, and university centers for excellence in developmental disabilities.
