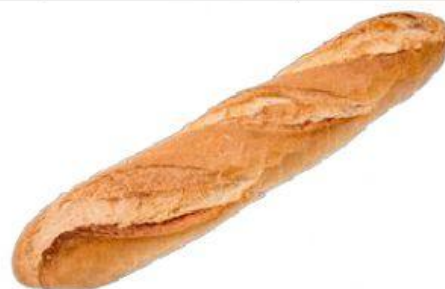

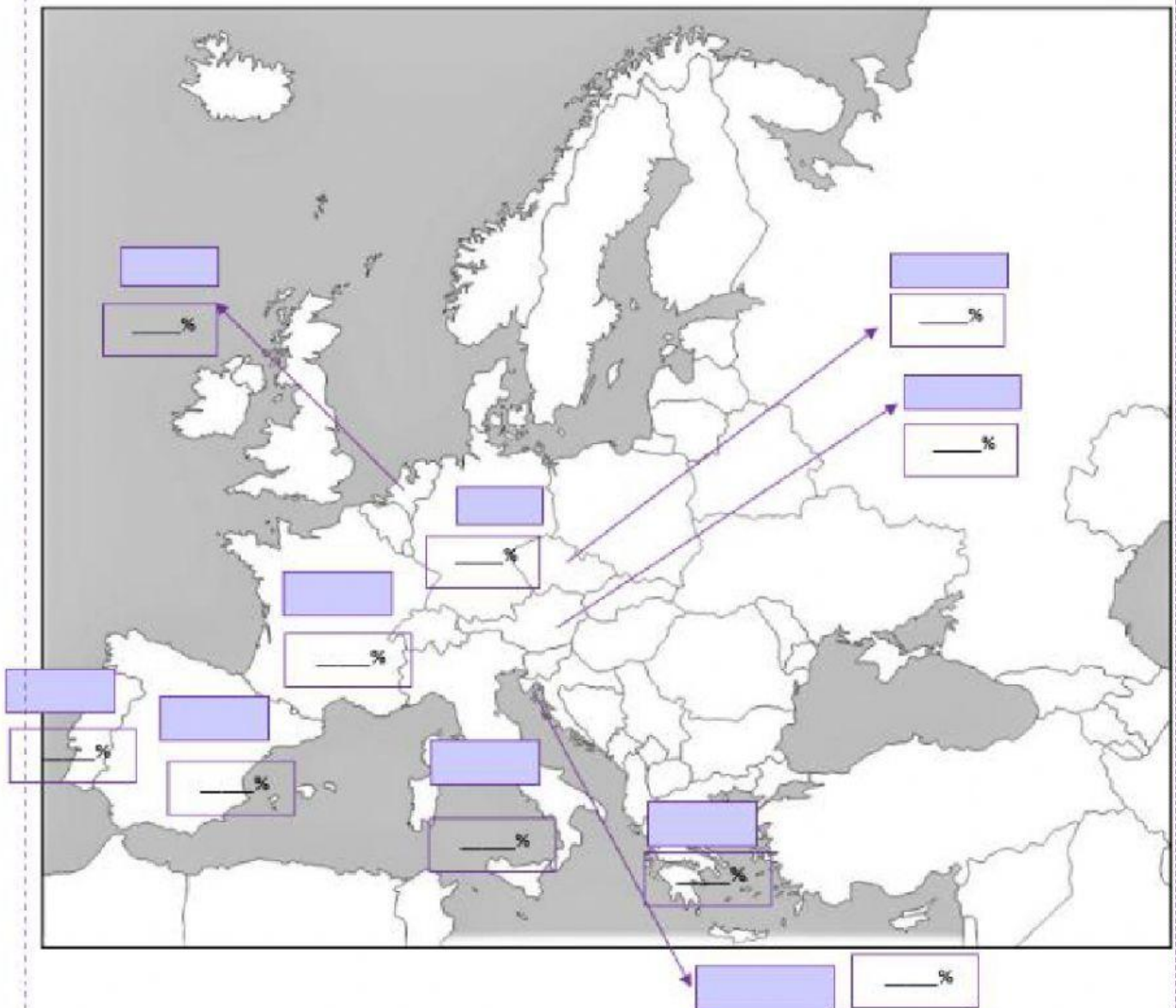
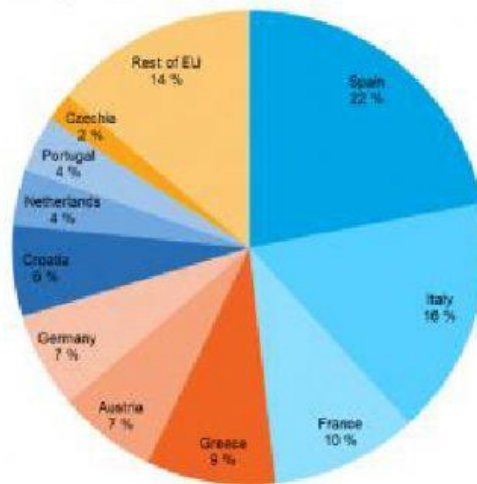

5. This chart shows us the most preferred tourism destinations in EU in 2019.

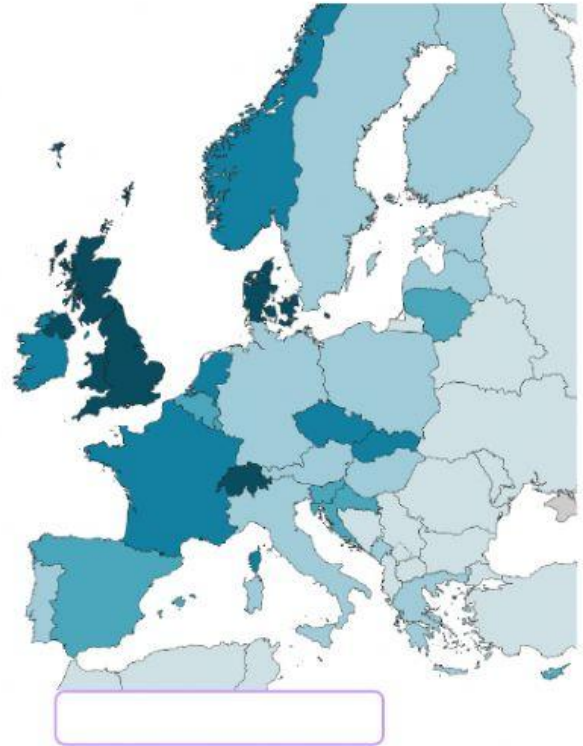
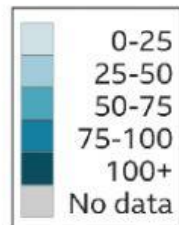
