CHARLES I WAS BORN IN SCOTLAND ON NOVEMBER 19, _____. HE WAS THE SECOND SON OF KING JAMES VI OF SCOTLAND AND _____. IN 1603, CHARLES MOVED TO ENGLAND AFTER HIS FATHER INHERITED THE ENGLISH THRONE. HE THEN BECAME THE HEIR TO THE KINGDOMS OF IRELAND, _____, SCOTLAND IN 1612 WHEN HIS OLDER BROTHER _____, PRINCE OF WALES DIED OF TYPHOID FEVER. AFTER HIS FATHERS DEATH HE BECAME THE MONARCH TO ALL THREE _____ ON THE 27TH OF MARCH IN _____. KING CHARLES I BELIEVED THAT HE HAD ABSOLUTE POWER AND A KING'S DIVINE RIGHT TO RULE WHICH WAS GIVEN TO HIM DIRECTLY BY GOD. WITH HIS PERSPECTIVE OF HOW HE SHOULD RULE, HE WAS DETERMINED TO GOVERN ACCORDING TO HIS OWN CONSCIENCE AND NOT HAVE TO ANSWER TO THE PEOPLE. ON THE _____ JUNE IN 1625 HE WAS MARRIED TO BOURBON PRINCESS _____ WHICH ALSO CAUSED A LOT OF PROBLEMS WITH THE PEOPLE HAVING FEAR OF THE ROMAN CATHOLICS DUE TO PAST EVENTS. _____ THEN FORCED THE CHURCH OF _____ TO CHANGE AND ADAPT TO HIGH ANGLICAN PRACTICES WHICH EVENTUALLY LED TO THE _____. THE ENGLISH CIVIL WARS(1642-1651) CAME AFTER THAT, WHERE CHARLES I FOUGHT THE ARMIES OF _____ PARLIAMENTS UNTIL HIS DEFEAT AND CAPTURE AFTER 1645. HE SURRENDERED TO A SCOTTISH ARMY THAT TRANSFERRED HIM TO THE ENGLISH PARLIAMENT AND WAS IMPRISONED. BY THE END OF 1648, THE PARLIAMENTARIAN NEW MODEL ARMY HAD TAKEN CONTROL OVER ENGLAND AND CHARLES I WAS CONVICTED AND _____ AFTER TRIAL FOR HIGH TREASON IN JANUARY OF 1649.
