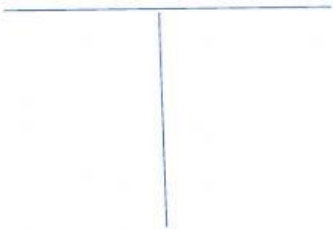

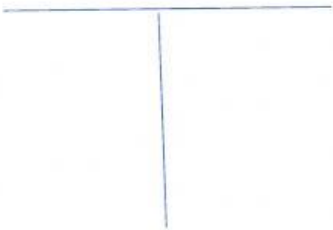

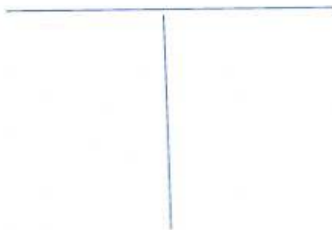
1. 1 Jan 2021 Started a business \$10,000 in cash.
