7-8 EXPRESSING ADVICE: *HAD BETTER*

(a) My clothes are dirty. I $\left\{ \begin{array}{l} \text{should} \\ \text{ought to} \\ \text{had better} \end{array} \right\}$ wash them.	<i>Had better</i> has the same basic meaning as <i>should</i> and <i>ought to</i> : "This is a good idea. This is good advice."
(b) You're driving too fast! You'd <i>better</i> slow down.	<i>Had better</i> usually implies a warning about possible bad consequences. In (b): If you don't slow down, there could be a bad result. You could get a speeding ticket or have an accident.
(c) You'd <i>better not</i> eat that meat. It looks spoiled.	NEGATIVE: <i>had better not</i>
(d) I'd <i>better</i> send my boss an e-mail right away.	In speaking, <i>had</i> is usually contracted: <i>d</i> .

8-7 CONNECTING IDEAS WITH <i>EVEN THOUGH</i> / <i>ALTHOUGH</i>	
(a) <i>Even though</i> I was hungry, I did not eat. I did not eat <i>even though</i> I was hungry. (b) <i>Although</i> I was hungry, I did not eat. I did not eat <i>although</i> I was hungry.	<i>Even though</i> and <i>although</i> introduce an adverb clause. (a) and (b) have the same meaning. They mean: <i>I was hungry, but I did not eat.</i>
COMPARE (c) <i>Because</i> I was hungry, I ate. (d) <i>Even though</i> I was hungry, I did not eat.	<i>Because</i> expresses an expected result. <i>Even though/although</i> expresses an unexpected or opposite result.

(a) I <i>prefer</i> apples <i>to</i> oranges. (b) I <i>prefer</i> watching TV <i>to</i> studying.	<i>prefer</i> + noun + <i>to</i> + noun <i>prefer</i> + -ing verb + <i>to</i> + -ing verb
(c) I <i>like</i> apples <i>better than</i> oranges. (d) I <i>like</i> watching TV <i>better than</i> studying.	<i>like</i> + noun + <i>better than</i> + noun <i>like</i> + -ing verb + <i>better than</i> + -ing verb
(e) Ann <i>would rather have</i> an apple than an orange. (f) <i>INCORRECT</i> : Ann <i>would rather has</i> an apple. (g) I'd rather visit a big city <i>than live</i> there. (h) <i>INCORRECT</i> : I'd rather visit a big city <i>than to live</i> there. <i>INCORRECT</i> : I'd rather visit a big city <i>than living</i> there.	<i>Would rather</i> is followed immediately by the simple form of a verb (e.g., <i>have, visit, live</i>). Verbs following <i>than</i> are also in the simple form.
(i) <i>I'd/You'd/She'd/He'd/We'd/They'd</i> rather have an apple.	Contraction of <i>would</i> = 'd.
(j) <i>Would you rather</i> have an apple <i>or</i> an orange?	In (j): In a polite question, <i>would rather</i> can be followed by <i>or</i> to offer someone a choice.
