After a Long Absence, Thierry Martin is Back!

Thierry Martin used to be among the best-known and most admired guitarists in the world. His last album, *La Defense* (named after the Parisian business district), had sold more than 1 million copies and was still listed at the top of music charts after being there for six weeks. In addition, he was scheduled to contribute to the albums of several award-winning vocalists.

Then three years ago, while skiing during a holiday in Colorado, he broke his left arm. He canceled all scheduled interviews and appearances and had to postpone his impending world tour. Fans followed his progress anxiously as he slowly recovered, and it seemed like he had given up playing altogether for a time.

But now he is back making new recordings. According to an announcement on Martin's Web site, his next album, *Normandy*, will be released this November by BBS Records. Featuring 20 new songs and contributions by several famous vocalists including British pop star Carly Fey and American singer James Norwell, it's almost certain to be a best-seller this holiday season.

To build excitement for *Normandy*, Martin released the first single from that album. Entitled "Summer Squall," it's a six-minute instrumental piece, incorporating hard rock influences. The popular music blog *MP3Stream* called the new single "one of his all-time greatest tracks."


Showing the Way Forward for Cyclist

Since it was first developed, Global Positioning System technology, or GPS as it is more commonly known, has been focused on finding more efficient and accurate ways to direct drivers to their destinations. The average GPS available is able to tell anyone in a vehicle the quickest and most efficient route from point A to point B, but it is unable to provide cyclists or pedestrians the same information.

A new mobile application called Ped-Routes, funded by the cycling association Two Wheels, aims to change all that. Developers from FGG Software have used GPS technology to create

maps that display less congested routes for a safer and more pleasant riding experience. In a move designed to make Ped-Routes appealing to more people, Two Wheels has also provided routes accessible to pedestrians.

Adam Jorgeson, the director of Two Wheels, said "We're very pleased with the new project and expect the first version to be launched before the end of the month. We are working with FGG on future versions that will provide cyclists with the option of taking the most scenic routes." Ped-Routes is downloadable for a cost of \$4.99, which gives users access for a period of one year.
