TEXT 2

Nine traditional Balinese dances have been recognized as part of the world's intangible cultural heritage following a UNESCO session in Namibia on Wednesday.

Balinese dances included on the list were the Barong Ket, Jaged Bumbung, Legong Keraton, Topeng Sidhakarya, Baris Upacara, Sanghyang Dedari and Rejang dances, as well as the Wayang Wong and Gambuh dance dramas.

"We are very pleased with the recognition; it enables Bali to receive protection in terms of traditional dance preservation as well as economic benefits in the future," said Bali Cultural Agency head Dewa Putu Beratha on Wednesday night as quoted by Antara news agency.

During the UNESCO session, Indonesia's proposal regarding the dances reportedly ranked 18th among a total of 35 countries. "The nine dances represent Balinese dance as a whole based on their historical concept, function and style," said Dewa.

According to Dewa, the Rejang, Sanghyang Dedari and Baris Upacara dances represented the Wali dance, which is usually performed during processions. Meanwhile, the Topeng Sidhakarya dance and Gambuh and Wayang Wong dance dramas are part of the Be Bali dance, known as a semi-sacred and ceremonial dance. The Legong Keraton, Jaged Bumbung and Barong Ket dances are a representation of the Balih-Balihan dance that serves social and entertainment purposes.

The Wali dance is said to have originated between the eighth and 14th centuries. The Be Bali dance and Balih-Balihan dances are believed to have come from the 14th-19th century and 19th centuries, respectively.

"The community has actively played an important role in preserving these traditional dances, especially the Wali dance. Meanwhile, the Bali provincial administration and its city and regency administrations should increase their role in preserving the Be Bali and Balih-Balihan dances during tourist events," said Dewa.

TEXT 3

Just as urbanization in America occurred during and alongside West ward expansion, the movement of people out of the cities and into the suburbs transpired over time. The term suburb commonly refers to an urban district on the outskirts of a city that grows more rapidly than its interior. The process of suburbanization began within the second quarter of the nineteenth century. The emergence of the industrial city at that time was spurred largely by developments in transportation. Until then the typical city had been a compact cluster of small buildings. People traveled primarily on foot, and goods were moved by horse and cart.

The early factories of the industrial age, built in the 1830s and 1840s, were located along waterways and near railheads at the edges of cities. Housing was needed for the thousands of people drawn by the prospect of employment, so within a short time, the factories were surrounded by mill towns of apartments and row houses that abutted the older, central cities. In response, many cities annexed these suburbs. In 1854, for example, the city of Philadelphia legally took over most of the county around it and the governments of Chicago and New York followed suit. Indeed, most great cities of the United States grew as they did only by incorporating the suburban communities along their borders.

With the acceleration of industrial growth came crowding and social stresses. When the first commercially successful electric traction line was developed in Boston, it revolutionized urban transportation by alleviating these problems. Transportation had previously been provided by a large network of horse drawn lines that had many disadvantages. The benefits of a new form of transportation based not on horse-power but electric power were immediately obvious.

Not only were electric streetcars cleaner, cheaper, and more efficient, but they were also much faster than horse drawn cars. Moreover, cities were able to offer cheap fares. Finally, businesses were quick to support local lines in their area because of increased business prospects: and local governments were eager to support the development of such lines, because long-term maintenance costs were very low once the initial expenditures had been made. Within a few years every major urban area had an electric streetcar network, which made quick, easy movement between distant points possible for large numbers of people. This new mobility encouraged people to look for housing farther out from the crowded urban core.

By the end of the 1950s, the American landscape had been completely transformed. The development of suburban tract houses had brought even more former city-dwellers outward into the suburbs. The standardization of these houses made the houses low in cost. The post-war prosperity of the 1950s had also given the urban middle class the desire and means to own single-family houses, and detached, suburban tract houses met this desire nicely.
