Novelist Opens Up About New Book

In author Jay Canfield's best-selling new novel, a writer named Tommy Malkin tries to escape his mistakes but only encounters new problems. The book, titled *Starting Over*, was released on July 4. I spoke with Canfield after his book signing at Trent's Books on 54th Street, which drew a large and enthusiastic crowd.

The novel, Canfield's fifth, is the tale of a formerly successful New York City author who has seriously ruined his career and hurt his marriage through selfish behavior. "He moves with his wife to a small seaside town and becomes a schoolteacher in an attempt to begin a new life, but finds it isn't that easy," Canfield said. He credits the basic idea for the story to his own wife, Andrea, who also collaborated with him on his best-selling tale of an American student in Japan, *Green Tea*. (Both Canfields were born and raised in Sedona, and they recently bought a new home here after years of world travel.)

Jay Canfield will be speaking at the Sedona Book Festival on July 15. He is currently working on another novel, his sixth. Based loosely on his own life, it will be released next fall.

In this excellent novel, the main character Tommy Malkin's life is falling apart. His work, marriage, and health are all on the edge of disaster. Having failed for years to repeat the success of his first book, he tries a change of location and career. I don't want to spoil the plot by saying more, but it doesn't end the way you'd expect!

Hollywood should definitely make a film based on this book. Canfield's characters are so vivid you feel like you know them. The visual imagery is beautiful, particularly the scenes on the beach. My only problem with the novel is that it should be about 50 pages shorter—some of the long descriptions felt unnecessary. But overall, this is his best book yet. I enjoyed it much more than his last one, which I thought was boring, despite its popularity. This one captures readers' imagination from the first page to the last, and leaves them with a lot to think about. Do yourself a favor and read it.

Construction on Freeway Affects Thousands

Drive times have gotten longer in large parts of the city as construction on the Clear Lake Freeway began on Monday. Workers are repairing rough surfaces and adding additional lanes over a five-mile section of the road. The freeway is completely closed in some areas, such as the Southland business district, while in others, only certain lanes are blocked off. Since the freeway connects the residential areas on the west side to Southland, thousands of commuters have had change their usual routes amid heavy traffic.

Public transport is affected by the road closures as well. Cross-city buses that carry hundreds of commuters to and from the area every day are being forced into lengthy detours. Neighborhood bus 14 to Southland University has temporarily ceased running. A spokesman from the Department of Transportation said that the bus will resume service by April 15.

The construction is expected to be completed by April 28. In the meantime, drivers have no choice but to be patient. The DoT spokesman said that once the construction is finished, residents will be grateful for the additional lanes and the smoother drive on the Clear Lake Freeway.

I've been following your paper's coverage of the construction on Freeway 16. We have to hold public officials accountable for their broken promises.
