The girls were Sarah Miller, Emily Davis, and Rebecca Turner.

To Officer Thompson, no case was solved until it was proven. One summer day in 2008, he heard a sudden yet **weird incident in the town**. **Three girls-with the same names as those from 1978 had disappeared**. This chilling coincidence sent shivers down his spine. As the news spread like wildfire across town, **its residents suffered into a widespread worry**. **Speculation were added by rumours of an evil entity** with a link to the long-unsolved case.

Officer Thompson was eager to reopen the unsolved 1978 cold case to uncover the truth and bring closure to them. He searched through **old pictures, police reports, and witness testimonies** as he went through **dusty files**. **In order to save the town from the rumours, he became more and more fixated on investigating** the mystery. The lives of the missing girls were investigated to see if there were any **connections between them in the past and present**. He spoke with friends, relatives, and colleagues from the 1978 case in an effort to **find any missed signs**. Each interaction revealed secrets of the peaceful town.

Eventually, his investigation led to the humble Mrs. Eleanor Collins, a retired teacher from Willow Heights Elementary. Mrs. Collins remembered a **little detail that had been overlooked as unimportant in 1978- a strange symbol cut into the wooden surface of one of the missing girls' desks**.
