In order to get the dark blue color that makes these jeans such a standout, the fabric is dyed twice to deepen the color of the denim. — [2] —. The item's label clearly states that some dye may rub off on light-colored fabric or upholstery until the product has been washed several times. — [3] —. It also suggests washing the jeans with dark colors only, as the dye may run in the wash.

It is unfortunate that you did not see these warnings and that your sofa has become discolored as a result. — [4] —. Our goal at Shoppe des Jeans is 100% customer satisfaction with every purchase.
