The Aboriginal Land Rights Act

The Aboriginal Land Rights (Northern Territory) Act 1976 was the first attempt by an Australian government to legally recognise the Aboriginal system of land ownership and put into law the concept of inalienable freehold title. The Land Rights Act is a fundamental piece of social reform.

ABORIGINAL FLAG, 1971

In 1971, Aboriginal artist Harold Thomas designed the Aboriginal flag.



The colours of the flag can be interpreted in different ways: the black could represent the Aboriginal people's colour or the night sky; the red can be seen as the red earth or as the blood that was shed when the Europeans arrived; the yellow is usually interpreted as representative of the sun.

Racial Discrimination Act

It made racial discrimination unlawful. Racial discrimination occurs when someone is treated unjustly, differently, because of their race or colour.

Vocabulary

Unlawful = *illegal* Occur = *se produire, survenir*
