The proliferation of smartphones and constant connectivity has sparked growing concern about digital wellbeing among psychologists and educators worldwide. **What began as tools for communication and productivity have evolved into sources of anxiety, distraction, and sleep disruption, prompting researchers to investigate the psychological mechanisms underlying problematic technology use.**

Digital wellbeing **encompasses** multiple dimensions affecting mental health and daily functioning. Users experience reduced attention spans, disrupted sleep cycles, and diminished face-to-face social skills. Mental health professionals observe increased rates of anxiety and depression correlating with excessive screen time. However, these challenges vary significantly across age groups and usage patterns, requiring nuanced interventions rather than blanket restrictions.

Screen time alone does not determine wellbeing outcomes; the nature of digital engagement matters critically. Passive consumption of social media content typically produces negative emotional effects, while active creation and meaningful online connections can enhance wellbeing. Additionally, the timing of device

usage significantly impacts sleep quality, as blue light exposure suppresses melatonin production. Many individuals struggle to establish healthy boundaries without external accountability structures.

Educational initiatives and technological solutions are emerging to address these challenges. Schools increasingly incorporate digital literacy programs teaching students to evaluate their technology relationships critically. Meanwhile, software developers create applications featuring usage tracking, scheduled breaks, and notification management. Companies implementing comprehensive digital wellbeing strategies report improved employee satisfaction and productivity. Nevertheless, cultural attitudes toward constant availability must shift before widespread behavioral change becomes possible.

Contracting marketing agencies to generate excitement through dramatic announcements proves considerably simpler than addressing fundamental challenges of radiation exposure, life support systems, and planetary protection protocols. [II] Consumers encounter these optimistic projections everywhere—billionaires promise lunar hotels, asteroid mining ventures claim imminent profitability, and satellite internet constellations expand without comprehensive environmental assessment. Corporate enthusiasm frequently obscures substantial risks and unresolved technical obstacles. Meanwhile, social media campaigns and investor presentations amplify these visions, circulating aspirational narratives far beyond scientific communities into mainstream consciousness.

The commercialization rhetoric emerged during the Space Shuttle era but has intensified dramatically since private launch capabilities matured. [III] Public fascination with space exploration, combined with declining government budgets, has created opportunities for commercial entities; many corporations, consequently, prioritize securing investor funding over demonstrating technological feasibility or addressing sustainability concerns. Regulatory frameworks governing commercial space activities remain fragmented and inadequate, struggling to address novel challenges posed by unprecedented private sector involvement. Financial markets, motivated by potential returns rather than scientific rigor, frequently reward speculative ventures despite limited demonstrated progress. [IV]

No sector better exemplifies these tensions than space resource extraction. Having recognized that outright dismissal of environmental concerns alienates stakeholders, industry advocates now frame asteroid mining as planetary salvation—redirecting resource extraction away from Earth. Press releases emphasize potential benefits while minimizing discussions of orbital debris proliferation, contamination risks, and monopolistic resource control. Why does this pattern warrant concern? Both governmental underinvestment and commercial overpromising threaten humanity's long-term space capabilities. Whereas insufficient funding limits scientific advancement, exaggerated claims erode public trust and divert resources from foundational research toward speculative ventures. Effectively, this dynamic creates a credibility vacuum, undermining serious space science while fostering unrealistic expectations that inevitably produce disappointment. Demanding transparent reporting of technical capabilities, rigorous safety protocols, and enforceable international agreements becomes essential if commercial space activities are to fulfill their theoretical potential rather than merely enriching early investors.
